### **Data protection principles**

Under the GDPR, there are six data protection principles that the Company must comply with. These provide that the personal information we hold about you must be:

- Processed lawfully, fairly and in a transparent manner.
- Collected only for legitimate purposes that have been clearly explained to you and not further processed in a way that is incompatible with those purposes.
- Adequate, relevant and limited to what is necessary, in relation to those purposes.
- Accurate and, where necessary, kept up to date.

- Kept in a form that permits your identification for no longer than is necessary for those purposes.

### Data we automatically collect

We use Google Analytics to monitor how our website is used. Google Analytics places several persistent cookies on your computer's hard drive. These do not collect any personal data. #### Personal data we collect

# Who do we share your data with?

## Where we hold and process your personal data

All our data is stored on an encrypted server/software accessed only by authorised office staff. We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

## Your rights

You have the right to obtain from us a copy of the personal data that we hold for you, and to require from us to correct errors in the personal data if it is inaccurate or incomplete.
